Subject: Constitution of Anti-Ragging Committee & Squad – Orders – Issued.

In order to ensure a safe, healthy and ragging-free academic environment in the College, and in accordance with the applicable UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions and the directions of the affiliating University, the Anti-Ragging Committee & Squad is hereby constituted with immediate effect.

For administrative convenience, the Anti-Ragging Committee and Anti-Ragging Squad shall function as ONE COMBINED UNIT in the College. The members of the unit shall collectively undertake preventive, monitoring, awareness and responsive measures relating to ragging within the College and its premises.

Functions and Responsibilities:

6. To ensure that students are informed about the Anti-Ragging Helpline, undertaking/affidavit requirements and other prescribed safeguards.
7. To maintain confidentiality, records of complaints, inspections, awareness programs and action taken.

8. To report serious incidents to the principal and, wherever required, to the competent University/Authority and law-enforcement agency in accordance with the applicable regulations.
